Unity Executive Director Appointed to National and State Hospice Organizations

Green Bay, Wis. – August 11, 2009 – Unity, leaders in hospice and palliative care, today announced the appointment of its executive director, Nicole Curran, to the National Hospice and Palliative Care Organization’s (NHPCO) Governance Committee and to the position of president-elect for the Hospice Organization and Palliative Experts (HOPE) of Wisconsin.

The NHPCO’s Governance Committee is charged with conducting and overseeing the recruitment, selection and evaluation of board nominees. Committee members are selected by invitation only, unlike the organization’s other national committees which select the membership by election. Curran is one of two representatives from the Midwest to serve on the Governance Committee. Her two-year term runs through 2010.

The HOPE of Wisconsin board is comprised of employees who represent the organization’s hospice provider members. This is Curran’s third term on the board, having served two three-year terms prior to her appointment to president-elect. She will assume the president position in January 2010.

Nicole Curran first joined Unity in 1993 and served as Director of Finance. Since 1998 she has held the position of Executive Director, overseeing operations of the organization’s hospice, palliative and bereavement programs throughout its twelve-county Northeast Wisconsin service area.

Curran holds a bachelors degree in accounting and business and a masters of business administration, and is also a licensed CPA. She resides in Green Bay with her husband, Patrick. They have two children and four grandchildren.
